#### Sheriff's deputies arrest man in fatal accident

Fort Bend County Sheriff's deputies arrested Devin Delvalle, 20, in fatal vehicle-pedal cyclist accident.

On September 28, 2023, at approximately 6:46 a.m., the Fort Bend County Sheriff's Office received a call regarding an accident involving a motor vehicle and a pedestrian in the

6000 block of Mason Road, Katy.

Upon arrival, deputies learned a juvenile male was riding his bicycle in a crosswalk when he was fatally struck by a vehicle being driven by Devin Delvalle. Delvalle remained at the scene, fully cooperative with deputies and investigators.

After further investigation, Delvalle was booked into the Fort Bend County

Jail and charged with Motor Vehicle Collision Involving Pedestrian Or Other Vulnerable Road User Within Area Of Crosswalk. His bond is currently pending magistration.

This incident remains an ongoing investigation.

"This is a very sad and tragic incident on both sides, for the driver, and especially for the victim's family," said Sheriff Eric Fagan. "Drivers need to slow down and pay attention, and that's extremely important in areas that are heavily traveled by

The victim was a student at Cinco Ranch High School and a member of the football team. The Katy Times is withholding the student's name out of respect for the family.

#### KP George hosts public meetings on \$865M bond issue

Fort Bend County Judge KP George is hosting a series of community meetings to inform residents about the 2023 Fort Bend County Bonds that will appear on the November 7 ballot. The bond propositions consist of 98 mobility projects for Proposition A for a total of \$712.6 million and Proposition B related to parks projects for a total of \$153 million, resulting in a total bond amount of \$865.6 million.

"These informative sessions are designed to provide the public with a comprehensive understanding of the proposed bonds and encompass a range of vital projects aimed at enhancing the quality of life in Fort Bend County," said a press release from the county. "These initiatives include, but are not limited to, infrastructure improvements, public safety enhancements, and parks and recreational facilities."

The second of these meetings took place Tuesday, September 27th, at Fulshear High School in Fulshear with about 60 people in attendance. Joined by Fort Bend Precinct 1 Commissioner Vincent Morales, County Engineer Stacy Slawinski, County Parks and Recreation Director Darren McCarthy and other staff, George outlined the projects covered by the bond in each of the county's four precincts as well as county-wide projects.



Business Association and president and CEO of KTX Window Cleaning.

Each panelist explained what she did and why she did it; Briones responded that in her office "we get to drive change." She spoke of the importance of creating structure and putting it in place "to guard your sanity." Thomas talked about the founding of Katy Moms Network and how that had evolved from a platform to help local moms to a platform that also helps small businesses grow.

Panelists also described their most exciting current project. "COVID took away our ability to connect," said Thomas as she described the special events she is launching in order to bring the "moms community" together. Briones talked about trying to build bridges among organizations to help them work together. "At the end of the day, the question is 'did you fix the problem," she said. McMartin described her plan to help real estate agents in her firm to create a legacy program through which they could earn future passive income from all their past hard work. Dr. Anyaoku mentioned her participation in "Leadership Katy," a program of the Katy Area Chamber of Commerce. Retherford discussed her plans for acquiring more government contracts through MBE programs.

tent brand messaging and other marketing strategies, as well as systems that they had created for their companies in order to manage communication with employees and to stay on top of the growth of their businesses. Speakers also explored challenges they faced as

entrepreneurs and discussed how they managed to stay motivated and how they each led their teams, as well as preventing personal burnout. Retherford talked about the importance of continuous learning. "You have to be methodical in your learning," she said.

"It was a natural fit for these two established Katy-based member organizations -- Katy Area Chamber of Commerce and Katy Business Association -- to market and facilitate this type of program," said Stacy Jacobs, VP/Business Development for the chamber.





#### Katy ISD students shine at Lone Star leadership camps

Ten Katy ISD students were among 840 outstanding 4th through 8th graders from across Texas who recently had the opportunity to hone their leadership skills at the 2023 Lone Star Leadership Academy camps. During the camps, which took place in Dallas-Fort Worth, Austin, San Antonio, Houston and Galveston, students completed problem solving and decision-making simulations, exercises in creativity, and practiced

Early detection is key in fighting breast cancer, says Candice Cross

If there is only one message that Candice Cross can share with the Katy community – it is that "early detection matters."

Candice discovered that she had breast cancer when she went in for her annual mammogram. Even though her grandmother had survived breast cancer, Candice never expected that it would happen to her.

When she received her diagnosis, she was in shock.

"Life stood still," Cross said. All I could think was my children and their futures. My oldest son was in his senior year at Katy High School and was about to have surgery himself. We were focused on assisting him with getting into The University of A&M and scholarship applications were due. I didn't have time to deal with this. I needed to focus on my son who had worked so long to get to where he was...how could this be happening now. You might think I was too focused on my son, but he had been fighting his own health battles since birth, with multiple surgeries and medical procedures. After 18 years, this was going to be his last surgery. There was no time for me to be sick, especially now."

But the challenges were just beginning. Her insurance wouldn't cover the hospital, but they would cover the surgeon.

"When I went in to get my mammogram, as they were getting ready to begin, a nurse came in and said there had been a mistake," said Cross. She was told that her insurance company will not cover the procedure.

"[The nurse] said you might want to reconsider having this done today. Flustered, knowing I had already taken off work, I let her know it would be fine and that I would just cover the cost myself. I had no idea how



important that decision would be in my life."

"In addition to this, later on, when I found out that I needed surgery, this time the insurance company said they would cover the cost for the surgeon but not the hospital," continued Cross. "I had done my research -- it was crucial that I have my procedure done at MD Anderson; however, that was now not an option. This was completely insane! Later that day my surgeon's nurse called and let me know. On that phone call, I realized how costly this would be to my family -- there was no way this could be happening. I told the nurse I was sorry, but I would not be having the surgery. I can just wait to see if it gets worse. No one knows for sure yet, so I still have time."

During the call Cross had no idea her surgeon was listening in and heard her response. Cross said that she was speechless, when her surgeon interrupted on the phone, saying "Hold on right there..." The surgeon went on to say the surgery needed to be done and she would go to any hospital that Cross' insurance would approve.

"There was such passion in her voice," said Cross. "She cared so much about me."

Cross ended up having treatment at Texas Women's Hospital in the Medical Center, under the care of her original surgeon.

"Because my symptoms were discovered at the earliest possible time, and I went for my yearly mammogram, I was blessed to only have a small surgical procedure," said Cross.

"If I would have waited or had chosen not to have my yearly mammogram, the results could have been very different."

The cancer forming cells that were found were detected very early on. "My surgery was very small compared to other women," said Cross. "With incredible technology, education, and the ability to have yearly mammograms have helped so many women."

"When my grandmother had breast cancer, there were no choices and no options -- you had to have a full mastectomy immediately. When she was alive, this was a disease that was never talked about. This might surprise you, but her sons didn't even know she had the surgery back then."

Following the surgery, Cross said that she did have to take some time off work from her job in real estate.

"However, my colleagues at Keller Williams Premier helped me every step of the way," she said. She also credits family and friends for their unwavering support. "I have the most incredible family," she said. "My husband and my children were there every step of the way. We knew whatever the outcome was it was part of our Lord's plan, and it would be okay."

"One of the most cherished memories I have from recovering are from my friends who didn't just support me during this journey but also supported my children," Cross added. "We tend to forget this can be very hard on the families especially the children."

Cross wants to emphasize the importance of early detection. "If I would have chosen to walk away the day I had my mammogram, my entire world would've looked very different," she said. "From one mom to another...I know how busy life can get. It can be difficult to think of ourselves; however, early detection can make such a difference." Cross added this quote from Charlotte Ross, which was sent to her from a friend: "Mammograms are really like a gift. You can either catch everything early or count your lucky stars because nothing was



Beverly Bivens Allen

A servant leader, Beverly Bivens Allen, a mother of five daughters, was hit hard with a recent cancer diagnosis of Stage 4 Triple Negative Breast Cancer (the most aggressive form). Today, as she faces the momentous challenge of overcoming breast cancer, she now shares her personal story of accepting the reality of change, working while healing and shining a

light on symptoms of Triple Negative

Like many other women, Allen skipped her mammogram during the pandemic. "It was the one and only time, I went without because I had no family history of breast cancer (so I thought), so I figured I'd be okay," she said. "In early 2022, I overlooked indicators such as an enlarged breast, an erect nipple and leather texture skin under the left breast. Unfortunately, on August 9, 2022, I was informed that I was positive for Breast Cancer by my OBGYN, Dr. Taryll Jenkins."

"My initial reaction was disbelief," continued Allen. "After talking to my OBGYN, I sat on my balcony in disbelief. My main concern was for my five daughters, Alexandria (29), Arianna (24), Alyssa (23), Amari (21) and Asia (20). I was praying that I did not pass breast cancer to them. Having to call each of them was the most devastating thing that I had ever had to do. Thankfully, after genetic testing, it was determined that the breast cancer was

After being diagnosed, Allen says that she had to share the news with others in an attempt to help someone else avoid the same faith. She posted a 25-minute video on Facebook filled with truth and humor to share with her family and friends, including all of the missed indicators she experienced and to encourage women to get a mammogram. friend saw the video after finding a lump, went for a mammogram and discovered she was positive for TNBC. "She thanked me for the video and I encouraged her to share her story," said Allen. "We were able to encourage one another along the way. Today, she is cancer-free. Unfortunately, after a series of tests and scans, I was diagnosed with Stage 4 Triple Negative Breast Cancer. I'm grateful that I was able to complete my last cancer treatment almost a year to the day of first starting chemotherapy.'

Starting September 16, 2022, Allen started six rounds of intense chemotherapy and had a left bilateral mastectomy, along with 12 cycles of immunotherapy and 33 rounds of radiation (with 6 additional rounds of chemotherapy). "I did not have any challenges receiving treatment," Allen said. "St. Luke's CHI provided a wonderful surgical experience with a diverse medical team of minority physicians, nurse practitioners and nurses. We cannot underestimate the value of cultural competencies when it comes to cancer treatment and care. The level of comfort I felt through my tears is indescribable.

Allen was able and determined to work and stay busy during her treatment, even taking Zoom calls during chemotherapy and immunotherapy sessions. As the Development Director for The Source, non-profit women's clinic, she was able to host a Charity Pickleball Tournament at the Houston Racquet to help provide access to healthcare for under-resourced women including vital breast exams. The event raised close to \$300,000.

Allen says she was supported during her fight by family and friends. "As a native Wisconsinite, I am grateful to both my Wisconsin and my Texas family and friends who sustained me during this cancer journey. I could not have made it without their continuous love and support. I am grateful for the countless prayers, get well cards, HEB

healthy meals and scheduled chemotherapy 'dates.' In addition, my The Source held "special" prayer calls and prayed for my healing during weekly staff meetings. I am so grateful that God led me to The Source for such a time as this.'

Allen has several bits of advice for others who are fighting breast cancer:

• A positive mindset is key. Avoid anything or anyone that steals your joy and peace.

• Supplementation is important. Allen said that a nurse told her not to worry about her Vitamin D level, later to learn that VItamin D deficiency is a direct link to breast cancer.

· Know your family's medical history. Allen's mother passed in 2019 of a stroke, so her focus was on heart health, with cancer never crossing her mind. After receiving the cancer diagnosis, Allen was forced to reach out to her father, with whom she had no relationship, to ask him his family history. At age 50, she learned that there was a history of breast cancer on her father's side of the family. In fact, he himself had had a mammogram to check for breast cancer.

#### • If you are told you have dense breasts, please continue to stay on top of your annual mammograms.

Allen also has advice for well-meaning friends and family who want to help someone fighting cancer.

"Show up!" she said. "Showing up does not have to be anything major. Send a card, host a prayer call or deliver a meal."

Allen's desire to educate others fuels her current involvement in the fight against cancer. "This month, as a part of health education, I will be sharing my journey with under-resourced women who may have questions about breast cancer," she said. "I believe my life has been spared to help others thrive. Also, I plan on creating a journal to help women navigate the journey and share more 'hacks' I've learned along the way."



Gi Pruden fights cancer in her personal life and as a service to the community

Long-time volunteer Gi Pruden has been quietly fighting breast cancer on the personal front as well as through her community service.

After her annual breast exam, her radiologist ordered an ultrasound to exam a suspicious lump. "I was suspicious after I had the biopsy, so I prepared myself for what could have been bad news," said Pruden. "When I was told it was cancer, I was sad and upset for my children, knowing how it would affect their future and upcoming lives as I would start treatment and surgery." Pruden's mother had passed away from colon cancer.

Following her diagnosis, Pruden underwent a lumpectomy and radiation at a surgical outpatient clinic in Houston. "Surgery went very smoothly, but I must admit it was during COVID, so I had to go into



surgery and treatments by myself which was lonely," she said. Pruden said that she was exhausted during radiation, and she had nausea after surgery and throughout radiation. She coped by getting as much bed rest as possible. "I disliked getting questioned so the quiet and letting me be was joyful."

Support and encouragement from family and friends helped her as she recovered. Her advice for friends and family who want to help: "Less questions and more doing - like, don't ask 'what do you need?' Send food or flowers, or a small gift - any messages of support. Questions made me reflect -- action items made me appreciate."

Her advice for others who are fighting breast cancer: "Keep moving forward -- doing the hard

work does lead to an easy life." Pruden said that she wants to bring awareness to the importance of annual checkups. "[They are] very very, very important -- that how my cancer was able to be found and treated." She added, "Size does not matter -- early detection does. Cancer can affect anyone; it does not discriminate. Plus, it's nothing that you did or could have done -- get treated and move forward."







#### KATY OUTLASTS JORDAN

#### TIGERS RISE TO THE TOP OF DISTRICT 19-6A

Katy was tested on Friday. The Tigers entered Friday knowing how important it would be to earn a win over Jordan this week and how the winner of District 19-6A could be determined by the matchup.

There was pressure, there was noise and there was talent on the other side of the ball, but none of this was new to Katy.

Jordan (4-1, 2-1) gave Katy (5-1, 4-0) everything it had, but in the end, Katy was able to overcome a 14 point deficit, beating the Warriors 42-35 and staying perfect in district play.




Morton Ranch came comes off a tough loss to Seven Lakes where things came all the way down to the wire.

week and then we put together a complete performance this week. We reminded the guys at halftime that this wasn't over and they had to come out and play for four quarters. Taylor is a tough, physical team and it was good to see these guys come out and have everyone do their job. If we focus on that and continue to do it, we'll have success."

Tompkins dominated up front on both sides of the ball, rushing for 275 yards while barely allowing over 100 yards rushing to a Taylor team with a strong offensive line. every day is so contagious. We feel it and we want to go out there, play for each other, play for this city and make everyone proud."

The Texans came out fired up and it showed on their opening drive. Houston easily drove down the field and despite two touchdowns being called back on penalties, still got into the endzone on a 2-yard pass from CJ Stroud to Nico Collins.

The Texans' defense though was the true story all day and it started from the Steelers' first drive of the game, where Jerry Hughes sacked Kenny Pickett and the next play Steven Nelson made a terrific play on the ball to intercept a pass and bring it back inside Steelers territory.

Houston's offense kept moving the ball through the first half but it was kept out of the endzone, three times settling for field goals, but still went into the locker room with a 16-0 lead and only allowed 53 yards throughout the half.

'The defense did a really nice job today and that's exactly how we want to play defense," said Texans head coach DeMeco Ryans. "We swarmed to the ball, we won the turnover battle and guys were flying around having fun and playing for each other. I really liked the way we played up front and then the guys behind them made plays. All the guys played together



and did their job. That's winning

The Steelers came out with a different attitude on both sides of the ball in the second half. Pittsburgh moved the ball on both of its first two possessions in the half but the Texans held the Steelers to field goals on both drives. The Steelers got the ball again with a chance to make it a one score game, but Jonathan Greenard made a huge play with a sack on fourth and one, giving Houston the ball back.

The Texans took momentum from there going into the fourth. Houston milked the clock and added a touchdown on a trick play pass from Devin Singletary to Dalton Schultz and Stroud capped things off with a 51-yard touchdown to Collins as the Texans came away with a huge win and a .500 record.

Stroud threw for 306 yards in the win and with that has thrown for 1,212 yards and six touchdowns while throwing zero interceptions through his first four games. It's the second most passing yards by a quarterback through four starts in NFL history and the third longest streak without an interception to begin an NFL career.

Houston will be on the road against Atlanta next week in what could end up being another winnable game as Houston tries to improve to a winning record.

"We don't care if people think we're good or if they think we're bad," Stroud said. "We're going to come out here and do what we do and compete. We're the man in the arena. What we focus on is ourselves and going out there and winning. Texans fans deserve to feel special. It isn't ok that we hadn't won a home game since 2021. We're turning this culture around and we are going to continue going to work every day so that people can walk around and root for us with pride. That's something we take personal."
