Trustees Vann, Wilson will not seek re-election

Two of the three Katy ISD trustees whose positions are on the May 6 ballot said they would not seek re-election.

Position 4 Trustee Leah Wilson said she would not seek a second term, citing a growing trend in school board politics where a more partisan, and less of a trustee-style

approach, is being pursued.

"It isn't about whether we're good stewards and good trustees for the district, but it's becoming about political ideology," Wilson said.

She said the trend is not happening just in Katy ISD, but in other area school districts as well.

"It's not just Katy, or uniquely Texas," Wilson said. In the last Cy-Fair ISD school

board election, she said, the three trustee races went to candidates who she said fit that description. Fort Bend ISD has had the same issue, she said.

"This isn't uniquely Katy, it's not just Texas; we're watching this nationally," Wilson said. "I think it's going to make it very difficult for people in the future to run if you have groups coming in and spending \$10,000-plus dollars on that. It's not some-

thing I agree with."

Wilson said trustees should be nonpartisan.

"I don't believe that a right- or left-wing political structure deserves to exist there," Wilson said, adding that in her view what was most important is making sure the district had the funds to build schools, hire the

Quilt to be auctioned to raise scholarship money

For many Katy-area students and their families, few objects match the iconic value of an FFA jacket.

The basic design of the blue and gold jacket dates back to 1933 and is so popular that

millions of jackets have been sold, according to the FFA website. They're considered a part of official FFA attire.

That iconic value has been incorporated into a quilt that will be auctioned this month, with proceeds benefiting the Katy ISD FFA students.

"We wanted to do something to celebrate

the 80th anniversary of the livestock show," Diana Robinson Elder, daughter of livestock show founder L.D. Robinson, said. "We wanted also to honor the chapters, students and advisors."

Elder said thoughts turned to the iconic

Council sets May 6 election

The Katy City Council Monday set its city election for May 6.

The council member-at-large position, along with one Ward A and one Ward B council position, will be on the ballot for voters to decide. The incumbents — Chris Harris, Janet Corte and Rory Robertson, respectively — have all filed for re-election. Nobody else had filed as of press time. Deadline for filing for a place on the ballot is Feb. 17. Candidates wishing to run on a write-in basis have until Feb. 24 to file the paperwork at the city secretary's office.

Harris and Corte were first elected in 2018 to two-year terms. They were re-elected to three-year terms in 2020, after Katy voters amended the city charter to provide for three-year terms. If re-elected, this would be their last term under term limits.

Robertson was first elected in 2020. If re-elected, this would be his last term under term limits.

Fitness Court at Katy City Park set to open Feb. 23

The city will host a ribbon-cutting ceremony for its new fitness court at Katy City Park. The ceremony is set for 10 a.m. Feb. 23 at 5850 Franz Road.

Blue Cross and Blue Shield of Texas, the city and National Fitness Campaign developed the fitness court to expand free access to high-quality workouts and create equitable access to exercise for communities around the state. The fitness court is the world's best outdoor gym that lets people use their own body weight to get a complete workout using seven exercise stations.

Memorial Hermann Katy Hospital using new robotic navigation, 3D imaging platform for cranial, spine surgery

Memorial Hermann Katy Hospital recently added a new intraoperative robotic navigation and 3D imaging platform designed to improve patient safety and surgical efficiency during cranial and spine procedures.

The first of its kind in Texas and one of the first in the U.S., the new platform can precisely track the movement of surgical

instruments and enable improved visualization of patient anatomy in real-time, increasing the efficiency of cranial and spine surgery. It also provides better avenues for collecting more reliable and accurate surgical data, potentially opening a window of opportunities for further technological advancements, including the development of predictive models based on anatomical and patient-specific risk factors.

"The hospital's new combined robotic navigation and 3D imaging platform improves and expands on traditional cranial and spine procedures as it enables intraoperative imaging capabilities that aim to increase reliability, consistency and surgical precision during minimally invasive procedures," said Wesley H. Jones, MD, a neurosurgeon with Memorial Hermann Mischer Neuroscience Associates-Katy Neurosurgery who is using the platform. "There are many benefits to patients, but most notable are improved outcomes and the ability to have advanced neurosurgical treatment right here in the area where they work and live."

According to the manufacturer, the robotic navigation and 3D imaging platform is the world's first technology to combine a rigid robotic arm and full navigation capabilities into one adaptable platform for accurate trajectory alignment in cranial and spine surgery.





jackets. She asked Jean Warnke, an award-winning quiltmaker who lives in Spring, if she knew someone who could create a quilt that incorporated elements for each of the nine Katy ISD high school FFA chapters. Elder said whoever made the quilt would be paid for their work.

"She said, no, I'll do it for free," Elder said. "She said, I wanted this to honor the chapters that your father started."

All nine Katy ISD high schools have FFA chapters, and their jackets have been incorporated into the quilt.

"She's always creating masterpieces," Elder said.

Elder said the quilt also features silhouettes of various types of livestock and images. On the other side of the quilt, she said, images show the history of farming in the United States.

Elder said the quilt would be on display at the livestock show, but did not know where precisely it would be displayed. She said they wanted to protect the quilt while making it visible to all. She said she and the scholarship committee were grateful to David Laird, the district's FFA events coordinator, for his and the district's support.

The quilt also honors Robinson, who came to Katy to create the livestock show. The L.D. Robinson Pavilion, which today is part of the district's Gerald D. Young Agriculture Sciences Center, 5825 Katy Hockley Cutoff Road, is named in Robinson's memory.

The L.D. Robinson Scholarships were created in 1970 and have been awarded since 1971. Jim Bacon received the first scholarship that year. In 2022, four students —

Kristen Justilian, Kailey Kulhanek, Kacki Kyrish and Lauren Sapp —received scholarships. In all, 138 scholarships have been awarded, Elder said.

Elder said she and other scholarship committee leaders have reached out to past scholarship recipients and board members to celebrate the livestock show anniversary. They will be honored at a buffet at 12 p.m. Friday at Midway BBQ, 8025 Highway Blvd.

L.D. Robinson is still remembered by longtime residents who remember when Katy was better known for rice fields than for today's explosive growth.

"He was a very kind, compassionate man," Elder said. "His greatest love was working with young people

and helping them to achieve their potential in anything they were in. He took many young people who didn't have a real strong supportive background, and he changed lives. He instilled in them the desire to succeed, and to believe in themselves and that all things were possible. His greatest joy was seeing his students achieve success."

charge. Magistration is pending.

The child is in stable condition. This incident remains under investigation.

"No child should ever be harmed in any way," Sheriff Eric Fagan said. "Our detectives are thoroughly investigating the incident and we remind everyone that making a false police report is illegal. Those responsible will be held accountable."

Katy man dies in Harris County Jail

A 23-year-old Katy man died Jan. 31 after suffering an apparent medical emergency in the Harris County Jail.

Kevin L. Smith, 23, of the 19200 block of Golden Wave Drive, was taken to the

jail clinic. There, Harris Health medical staff saw him. At approximately 10:40 a.m., Smith was taken to the hospital by ambulance. He was pronounced dead at the hospital at approximately 11:25 a.m.

Smith had no obvious physical injuries, deputies said in a statement.

The Houston Police Department is investigating the death in accordance with state law that requires all jail deaths to be investigated by an outside law enforcement agency.

The Sheriff's Office Internal Affairs Division is also investigating to determine whether all applicable policies and procedures were followed, which is standard following the death of an inmate. The Harris County Institute of Forensic Sciences was to perform an autopsy to determine the cause of death.

In addition, the death has been reported to the Texas Commission on Jail Standards.

Smith faced a continuous violence against the family charge and was free on \$10,000 bond. According to the charging document, Smith allegedly assaulted a woman he was dating on at least two occasions last year.

best teachers, and provide public education in a safe environment.

"I love this district and there are so many great people who work in our district," Wilson said.

Position 3 Trustee Ashley Vann also said she would not seek a fourth term. She said she felt she had done good work in her three terms on the board, and that it was time for someone else to serve.

Vann was first elected in 2014. She was re-elected in 2017 and 2020. Her 2020 bid was unopposed. She previously held other volunteer roles related to education, including roles with the

Katy ISD Education Foundation and PTA roles with her children's elementary, junior and high schools.

Each trustee race will be contested. Four candidates have filed for Vann's position 3 seat. They are Bruce Bradford, a mortgage loan originator; Shawn Miller, a college professor; Shana Peterson, who is retired, and Amy Thieme, a realtor.

Three candidates have filed for Wilson's position 4

seat. They are Erica Brettell, a stay-at-home mother; Morgan Calhoun, a stay-at-home mother, and Cicely Taylor, an education administrator.

Position 5 Trustee Greg Schulte, an engineer and business owner, has filed for re-election. He is seeking his second term. He has drawn one opponent, Mary Ellen Cuzela, a Katy ISD substitute teacher.

Filing deadline is Feb. 17.







When she finally "retired" she began her own non-profit: Katy Area Ride Service (KARS) to help transport the elderly and disabled to doctor appointments and local activities. Kathie was also a big supporter of our military and all first responders.

She had many interests and passions along the way. She loved to tinker in her garden but tended towards a black thumb (the only one the family knows to have successfully killed an artificial plant). She had a love of trains, cows, Hallmark movies, theatrical productions (her absolute favorite being The Sound of Music), swimming, playing piano, and watching HGTV. She had an addiction to chocolate and milkshakes and loved going with her dear friend and her friend's dog to get ice cream (yes,

this included getting her friends dog ice cream, too). She had a fervent belief in angels and collected angel figurines. She also had a smaller collection of cow items.

Spartans continue hot streak with win over Cinco Ranch

Seven Lakes had high expectations heading into this season.

Coming off a District 19-6A championship and a regional quarterfinal appearance, and with a wealth of talent returning, the Spartans knew they had the potential to have a very strong team on their hands if they put things together.

So far they've done just that, starting the year 13-0-1 with a 7-0-1 record in district play and excelling on both sides of the ball, as the Spartans have met their own expectations with a very strong start to the year.

"This team just has a special connection overall," said senior centerback Katie Lennon. "As people we really just get along and we're close. It makes things more fun, the practices, the games, they never get old because we all get along with each other and want to play and win for each other. That's what made this group so special and successful this year."

Seven Lakes continued their dominant run on Saturday, with the Spartans coming away 3-0 winners over Cinco Ranch to remain four points ahead of second place in district, using two early goals to jump out to a fast start and take care of business against the Cougars.

"I was proud of the way they played today," said Seven Lakes head coach Kaitlyn Edison. "They came out and did what they needed to do today. The girls knew what we had to do to be successful and win this game and they played the way they needed to play. They stuck to the gameplan, believed in each other and executed. When we do that and execute, then it's a different type of game."

It took only four minutes for the Spartans to get their first goal as they threatened the Cinco Ranch goal early and often.

Kennedy Reed whipped in a cross to the back post and while no Seven Lakes player was able to get a head or foot to it, it held the keeper who was waiting for a touch and the ball ended up in the back of the net for a Reed goal.

Just two minutes later, the Spartans doubled their lead as Haydan Erck scored directly from a corner, whipping in a ball that

went right across the face of goal and inside the far post for an Olimpico as the Spartans went two up early in the first half.

"It was huge for us to get those two goals and get them early like that," said Seven Lakes senior goalkeeper Maddie Rich. "Especially on a windy day like today because we had it to our backs first so we needed to take advantage of that. They wanted to play things through the air and they have some good players who can win those balls, so to get two goals, be able to focus on that and

get momentum shifted our way is exactly what we needed to do in that situation."

The Spartans made it 3-0 in the 28th minute when Erck whipped in another cross that Vicky Ott headed for a goal, allowing Seven Lakes to comfortably see out the match.

"Haydan is just such an unselfish player and it's really special that someone with her talent is as selfless as she is," Edison said. "She understands her movement opens up a lot of space for other players and with the other dynamic players we have, it allows them to capitalize on that. We have a lot of players that can draw those defenders and then release the ball quickly and find the open player and that's just awesome to have in a group."

The Spartans are chasing their second straight district championship, and while there is still a ways to go, the team is confident in themselves and believes they can battle with anyone. A big part of that belief comes from the Spartans' defense, which has been stellar in every way this season and has been a main catalyst to their success, only allowing one goal through 14 games. With a defense like that, the Spartans know that they can do a lot of things this year.

"It's the leadership we have back there, on the backline and at goalkeeper — we have so many individuals that stand out, but as a unit they're even better than individually," Edison said. "They deserve every bit of praise they get because you can't count the goals that they keep from going in. It's easy to see the attacking stats, but it's the hard work at the back that allows that to happen. All of our players know how to defend, and it's about all 11 and that's what is so key with these players, is they all know how to play the different parts of the game."

With district title in hand, Spartans are ready to make a run

When Seven Lakes coaches and players met before the season to go over their goals, they didn't want to sell themselves short.

Even with a group that had players stepping into new roles and learning, the Spartans knew they had something special on their hands, and they knew that the sky was the limit for this year.

So, they set the loftiest of expectations for themselves, and made their top goal making it to the state tournament.

"We set a lofty goal and we're not there yet," said Seven Lakes head coach Shannon Heston. "We're striving to get there but our focus is hitting milestones along the way, focusing on those. We know that we

have to be focused on the here and now, taking care of what's within our reach and knocking things down until we reach our biggest goal. But we feel like that is the right ultimate goal for us — with our talent, why not us?"

Those smaller goals along the way have been key for the Spartans, as they have been building towards the playoffs all season. The first check on their box was winning district, and they have done that — now they've turned the page towards going undefeated in the District 19-6A season and taking the playoffs round by round.

"That's the next accomplishment we're looking at," said senior center Josh Akpovwa. "Just to bring another district championship here is huge, but to have a chance to go undefeated in district while

doing it is a really cool thing to think about. But we're not done here — we know how important it is to keep the right mindset and we're going to stay focused on our goals."

Last year's Seven Lakes team also won a district championship, but the team's ultimate goal was cut short, when they suffered a heartbreaking 53-50 loss to Bellaire in the area round.

That feeling of a playoff run cut short is something last year's varsity players still feel, and it's a feeling they aren't interested in having again with a group that includes some of the best talent the school has ever had.

"This is the time where you have to lock it in," Akpovwa said. "You have to work harder than everyone else and embrace

that grind and intensity. We have a great young team — this team has the talent to go to state, I'm sure of it. We just have to be better every single day, play defense and with a great motor. We have the pieces — we just have to continue to improve."

That is the mindset for every Seven Lakes player. They know how much things will need to be elevated in the playoffs, and if they want to reach their biggest goals, they know that they can't let up for a single game.

"Everyone has to be on the same page and we have to be ready," said junior guard A.J. Bates. "We have to be at our best every night — we have the talent, the depth, coaching and everything you could want. Now we have to go out and show everyone we have what it takes."

get out in transition, kept the Cougars from getting in a rhythm and made his teammates comfortable knowing they could be aggressive on the defensive end.

"It's just a credit to him and all the work he's put in," said Seven Lakes head coach Shannon Heston. "It just lets our guys play free and with confidence on that end, because he will erase mistakes. It's just something special when he's in a zone like that, it makes us a tough team to beat when he plays like that."

Seven Lakes only led by two after the first quarter after Cinco Ranch trimmed into things but turned that into a five-point lead at halftime and a 10-point lead at the end of the third quarter as they continued to pull away.

A big part of that along with Akpovwa was A.J. Bates, who finished the game with 23 points as well as a number of assists. Bates, last year's district MVP, continued to show why he is able to compete with anyone he goes up against in the state.

"We just had to run the offense the right way tonight," Bates said. "Our pace is what makes us and we want to be fast, but tonight when we slowed things down and really got into our offense it ran well and we were able to control things. We just came out the right way and we just showed our dominance — that's what we have to do every game."


The Spartans have accomplished their first goal of the year, with winning a district title, but are still in search of many more, including going undefeated over the course of the district season. And they aren't planning to let up with just one game to go before they head into the playoffs.

"It's been a while since that's happened for a Seven Lakes team and we want to do that," Bates said. "We can't get complacent now. That's our next goal is to go undefeated in district before we head into playoffs — now we have to go accomplish it."

the way we play it even if we switch it up. Whether we're in a zone, pressing full court or half court, they know their job and know exactly what they need to do on defense."


