Katy, KISD, Brookshire officials sworn in

Amy Thieme, Morgan Calhoun and Mary Ellen Cuzela were sworn into as office as members of the Katy ISD Board of Trustees at a May 11 meeting at the district's Education Support Complex, 6301 S. Stadium

It is the first election for the three women. Thieme, a realtor, defeated Bruce Bradford. a mortgage loan originator, and Shawn

Miller, a professor, to win the position 3 seat vacated by Ashley Vann, who did not seek re-election.

Calhoun, a stay-at-home mom, defeated Cicely Taylor, an education administrator, and Erica Brettell, a stay-at-home mom, to win the position 4 seat vacated by Leah Wilson, who did not seek re-election.

Cuzela, a Katy ISD substitute teacher, defeated Shana Peterson, who is retired, to win the position 5 seat vacated by Greg Schulte, who did not seek re-election.

After the swearing-in, trustees met in executive session to select their officers. Position 1 Trustee Victor Perez was chosen president, Thieme was chosen vice president and Position 7 Trustee Dawn Champagne was chosen secretary.

Brookshire mayor, council members sworn in

Mayor Darrell Branch and two aldermen were sworn into office May 11 at Brookshire City Hall, 4029 5th St. in Brookshire.

Branch, a facility manager, defeated former Mayor Eric Scott, who listed himself as unemployed on his campaign form, in a rematch of the 2019 election. Branch was first elected to the mayoralty that year. He was re-elected in 2021.

Tony McAnelly, a retired nonprofit executive, was sworn in as position 2 alderman, defeated Jimmy Sanders, a

Dollar General Literacy Foundation awards \$3,000 to Neighborhood Kidz **Club of Katy**





Katy City Council

The Katy City Council was expected to meet in a special May 17 meeting—after press time-to canvass election results for the Ward A council race. In that race, incumbent Janet Corte, a retired IT manager, was re-elected, defeating Cara Bonin, a contractor. Corte was expected to be sworn in at the regularly scheduled May 22 meeting.

Meanwhile, incumbent Council Member-at-Large Chris Harris and Ward B Council Member Rory Robertson drew no opponents in the election. Their elections were canceled and they were declared elected under city law because they drew no opponents. Both men were expected to be sworn in at the May 17 meeting.

State law requires that local election results be canvassed within a certain number of days after the election, which is why the council will hold the special meeting.

who served library patrons over the years. "They had a great opportunity to do things

that were good for the community," Elder said. Libraries continue to play an important role today. Elder said about 30% of students in schools today cannot read. Some, he said, could not write, and others could not do a basic math problem.

'We have a definite need for reading to take hold and help these young students get their education," Elder said. "There should be no one that doesn't have an opportunity to read and have a form of literacy in their life."

Elder said that reading is a top priority, probably the top priority, that one can have in a school, a city or a county.

"If you can't read, it's going to be a long unhappy way in life because everyone around you is going to be able to read," Elder said. 'This library has probably helped more people in Harris County, Katy and surrounding areas achieve a lot of different skills."

Elder said the city of Katy has been fortunate that the library has been available for the community. He said it is special for the families that use and have need for it.

The May 10 celebration was for the building, which opened in 2003. The library goes back even further.

According to its website, the Katy Library dates back to 1921, when the Katy Garden Club opened it in private homes.

Later, the library shared space in a grocery and furniture store before operating out of the old Katy Fire Department on 2nd Avenue. Construction on the current library building

began in 2002.

While the city itself does not have a library department, the Katy Library is considered the city's library because it falls within the city limits. The library itself is part of the Harris County Public Library system.

Boggs, who celebrated her 30th birthday at the party, was named director last August.

The vastness **Newton Minow** leaves behind

ewton Minow will always be remembered for a 1961 speech in which he described television as a "vast wasteland." However, late in life he became less concerned about TV's wastefulness and more troubled by its very

The legendary former FCC chairman knew a thing or two about television, having studied it for most of his adult life. He died at his Chicago home the other day at 97 without ever reconciling his love-hate relationship with the medium that so profoundly affects our lives.

Minow was actually an inveterate fan of much that TV had to offer, and his real purpose in that infamous speech to the National Association of Broadcasters was to challenge and inspire. "I am in Washington," he explained, "to help broadcasting, not to harm it; to strengthen it, not weaken it; to reward it, not to punish it; to encourage it, not threaten it; and to stimulate it, not censor it. Above all, I am here to uphold and protect the public interest."

In conversation with me 60 years after delivering the speech, Minow explained, "Our goal was to enlarge choice for the viewer. When I was at the FCC there were only two-anda-half commercial networks. Now we have public TV, cable, satellite, pay tv, with almost unlimited choices. It's a totally different medium."

Television's enormous growth-with digital platforms joining the delivery systems Minow mentioned—prompted him to gradually reevaluate his views. "I used to think providing more choice was in the public interest," he told me, "but I am not sure today."

In lambasting TV programming in the 1960s, Minow cited "a procession of game shows, formula comedies about totally unbelievable families, blood and thunder, mayhem, violence, sadism, murder, western bad men, western good men, private eyes, gangsters, more violence, and cartoons." That's still a reasonable way to summarize much of what's on today. But modern viewers are also enjoying what many call a

second Golden Age of programming.

So, what's the problem? "Fractionalization of the audience provides more choice," Minow said, "but we pay a big price. Our country now is much more divided because we do not share the same news or believe the same facts."

Barack Obama, who awarded Minow the Presidential Medal of Freedom in 2016, praised him for "helping launch the satellites that made nationwide broadcasts possible, cementing presidential debates as a national institution, helping usher in public television, and reminding the media of its obligation to foster a well-informed citizenry."

But Newton Minow's good intentions—beginning with the speech that launched his career in public service—were not enough. "Back then," he told me, "Walter Cronkite was the most trusted man in our country. Who is trusted today?"







Keys earns 3 medals to lead way for Katy ISD at state track meet

Jayden Keys is no stranger to the medal stand.

Over the course of his first two years in high school, the Tompkins junior found his way to the state podium on two occa-

sions, earning bronze medals in the long jump in both his freshman and sopho-

more year.

But Keys one upped his past results last Saturday at the Class 6A state meet, the junior took home three medals from the meet and finished with 18 points, propelling Tompkins to a ninth place finish as a team just by himself.

Keys finished third in the long jump, third in the 100-meter hurdles and third in the 300-meter hurdles to take home three medals from this year's state meet, and bring his total medal total over the course of his three years at Tompkins to five.

Keys finished the 100-meter hurdles with a time of 13.82 seconds and the 300-meter hurdles with a time of 37.23 seconds, while making a jump of 23-.475 in the long jump for his bronze medals.

Paetow's DJ Hicks also earned a medal at the state meet, placing third in the discus. Hicks threw 182-06, coming very close to the silver and gold medalists who

threw just one and two meters further. Madison Carlton rounded out the medalists for Katy ISD, placing third in the high jump.

Carlton, a freshman from Seven Lakes, was an alternate coming into the meet but had a very successful day, clearing 5-06 to come in a tie for third with San Antonio Reagan's Mackenzie Dagrosa. Seven Lakes' Chineye Uzoh also jumped 5-06 and came in sixth in the high jump for her efforts.

In the pole vault, Taylor's Addison Schroeder became the first female athlete to compete in the state meet for the Mustangs and also scored, coming in sixth place with a jump of 12-00, while Cinco Ranch's Bella Borreson came in seventh place in the same event with a jump of 12-00 also.

Seven Lakes' Janey Campbell did well in both of her events. She finished fourth in the shot put with a throw of 43-6.25 while getting seventh in discus with a throw of 136-8. Mayde Creek had a strong performance out of Elijah Feguson, who finished in fourth with a time of 47.55 seconds while Jordan's Tiyan Ogbeide came in fourth in the 800-meter run. Katy's Elizabeth Brooks came in eighth in the same event while the Tigers had another state finisher in Damacio Hooks who came in

sixth in the triple jump. Max Austin came in seventh in the pole vault, jumping 15-6 to round out the Katy ISD competitors.

In Class 4A, Royal took home three medals, two of which were gold.

The Falcons finished first in both the 400-meter relay and 800-meter relay with runs of 36.72 seconds in the 400-meter relay and one minute, 38.73 seconds in the 800-meter relay. Diamond Barrett finished third in the 200-meter dash with a run of 24.54 seconds while Royal had another state finisher in J'Marcus Wilkerson, who finished eighth in the high jump with a jump of 6-02.







Cinco kept that one run lead until the fourth inning, when Memorial tied things up, but immediately the Cougars had an answer.


The Cougars got runners on and then Ethan Muniz drove in two before another run was brought in when Memorial's pitcher balked, putting Cinco ahead 4-1.

Katy grads Galvin, Ojomo find NFL homes

Two Katy grads found NFL homes as Moro Ojomo was selected in the NFL draft and Connor Galvin became an undrafted free agent signing.

Ojomo was selected in the seventh round with the 249th pick of the draft by the Philadelphia Eagles. Ojomo was part of the 2017 Katy team that lost to Lake Travis in the state semifinals and was a was named the defensive most valuable player in the district his senior season before going to the Univeristy of Texas for his collegiate career. There he played in 50 career games and made 30 starts for the Longhorns, garnering second team All-Big 12 accolades in 2022. He had 95 tackles over his career at Texas, 13.5 of which came as tackles for loss and he had five sacks. Ojomo was named as Ray Didnger's top sleeper pick of the draft and is known for how hard he plays and his size and strength.

He joins a stacked defensive line in Philadelphia, that includes top 10 draft choice Jalen Carter, Jordan Davis, Fletcher Cox, Brandon Graham and more where he will be given time to grow but still could get opportunities as the Eagles like a strong rotation in their

Galvin went undrafted before signing a free agent deal with the Detroit Lions in a move where he hopes to prove himself and make the final roster.

Galvin was part of that same 2017 Katy team that made it to the state semifinals, being named as a four star prospect before going to Baylor where he was a five year starter at left tackle. He was a First Team All-Big 12 selection in 2022 while being named honorable mention All-American and Second-Team All-Texas, he was also named Big 12 Offensive Lineman of the Year in 2021. Galvin broke the Baylor record for most career starts with 58 while becoming fourth all time in program history in games played with 58. Galvin joins a strong group in the Lions offensive line that they also upgraded in the draft.

Another Katy graduate will also get an opportunity to play at the next level, as JuanCarlos Santana was invited to the Seattle Seahawks rookie mini camp. Santana had 43 catches for 843 yards and 13 touchdowns his senior season for Katy before going to Tulsa, where he was a three-year starter. He played in 47 career games with 34 of those being starts, totaling 2325 yards and 15 touchdowns on 157 receptions in his college career, with six games of over 100 receiving yards.

Houston gets aggressive in NFL draft

The Houston Texans weren't shy in this year's NFL draft, making moves from day one to day three and looking to strengthen the team in multiple ways.

The draft was highlighted by the Texans shock trade with the Arizona Cardinals, as Houston traded up to the third pick in the draft to take Will Anderson out of Alabama, after taking CJ Stroud with the second pick in the draft, but that was far from the teams only move. The Texans made a number of trades after that as well.

It started with Houston trading back into the second round and selecting Juice Scruggs with the 62nd overall pick. A center out of Penn State, Scruggs, who played through his redshirt senior year for the Nittany Lions, earned Third Team All-Big 10 honors this past year and started all 13 of his teams games at center. He will help the Texans continue to develop an improving offensive line.

The Texans continued their trading ways by trading up in the third round to select Tank Dell from the University of Houston, Dell was one of the most fascinating

prospects in the draft, as he is one of the most explosive players in the draft, but lacks size which made him drop to the third round.

Dell was named Third Team All-America after his junior season, where he made 13 starts and had led the nation in receiving yards and touchdowns. He caught 109 passes for 1398 yards and 17 touchdowns, averaging over 107 yards per game receiving. Dell also is a huge

threat in the return game. The Texans then bolstered their defense in rounds four and five by taking TCU defensive tackle Dylan Horton and Alabama linebacker Henry To'oTo'o before selecting Notre Dame offensive lineman Jarrett Patterson in the sixth round.

Houston made another interesting selection in the sixth round when they drafted Iowa State wide receiver Xavier Hutchinson. Hutchinson was a First-Team All American in 2022 and in his final year with the Cyclones caught 107 passes including six touchdowns. He gets added to a very crowded wide receiver room but has a chance to prove himself and get a roster and rotation spot. The Texans final draft pick was Pitt defensive tackle Brandon Hill.
