Council approves emergency sewer pipe repair

The Katy City Council approved \$47,235 in emergency repairs to a sewer pipe along 1st Street running from Avenue D to Avenue C. The council gave its approval at its May

22 meeting at City Hall.
City Finance Director Andrew Vasquez,
in a memo to the council, wrote that the

money for the work would come from the city's enterprise fund reserves.

In another action, the council approved a deal with Rain for Rent, which will provide a temporary tank for Water Plant 6. The four-month rental will cost \$27,036, which

Corte sworn in for third term as Ward A council member

Ward A Council Member Janet Corte was sworn in for a third term of office at the meeting. Corte was first elected in 2018 to a two-year term, then re-elected in 2020 to a three-year term after Katy voters approved extending terms of office to three years.

Corte missed the May 17 meeting in which Council Member-at-Large Chris Harris and Ward B Council Member Rory Robertson were sworn in. Neither drew an opponent and were declared re-elected, under city law, in February. Corte, a retired IT manager, defeated Cara Bonin, a contractor, to win re-election.

Corte thanked her family for supporting her council activities, and said many times they have taken second place to city events.

they have taken second place to city events "I greatly appreciate your love and support these past five years," Corte said.

Corte said she looked forward to continuing her work with Mayor Dusty Thiele and her council colleagues. They work well together, she said, and have a great momentum going. She her priorities would remain excellent public safety, improving flood control, replacing aging infrastructure and improving parks and recreation.

This is the final term for Corte, Harris and Robertson under term limits. Their three-year terms expire in 2026.



Local economy remains strong, but slowing, economist says

The Texas and Houston-area economies are slowing in part because of elevated inflation and rising interest rates, along with a slowing global economy and uncertainty over the Russia-Ukraine war, an economist said.

Luis B. Torres is a senior business economist in the research department of the Federal Reserve Bank of Dallas. He presented his findings at a May 18 economic forecast session sponsored by the Katy Area Chamber of Commerce. The meeting took place at the chamber headquarters, 814 East Ave., Suite G.

Despite the slowing economy, Torres said, the early 2023 Texas job growth rate remains strong. The current job growth rate is 3.9% in Texas, compared to 2.2% nationally. These moderate rates are highlighted both by a downturn in high-wage service sectors and continued weakness in the manufacturing sector, he said.

In terms of Texas markets, the Dallas-Fort Worth metro job growth is the strongest in the state, at 30.4%. The Houston area is second, at 24.1%. Austin (9.4%) and San Antonio (8.3%) follow.

Yet despite this growth in jobs, Torres said, energy related jobs are not yet back to their pre-pandemic level. Only two energy-related categories—non-farm and chemicals—have seen job growth. Other categories, most notably oil and gas extraction and agriculture,

It has been nearly seven years since Eden Ganzerla lost control of her car while driving to work and crashed into a retaining wall, breaking nearly every bone in her body. Since then, she has endured thousands of hours of physical, occupational and speech therapy, the result of one fateful decision to not

wear her seat belt.

Ganzerla now struggles with a traumatic brain injury, speaks with the aid of a computer, and is slowly learning how to walk and talk again.

"Before the crash, Eden was very outgoing and talkative, living life to the fullest with her animals and friends," John Ganzerla, Eden's father, said. "Now, she lives with us in Dripping

Springs and is dependent on her mother and me for even the simplest everyday tasks."

Unfortunately, choosing to not wear a seat belt is an all-too-common mistake in Texas. In 2022 there were 1,258 people killed who were not wearing their seat belt, a 2.5% increase from the year before.





Agencies team up to caution drivers about drunk driving during holiday weekend

The Harris County Sheriff's Office, the Harris County District Attorney's Office, Harris County Constables, the Texas Department of Public Safety, American Automobile Association (AAA) and Mothers Against Drunk Driving are joining forces ahead of the Memorial Day holiday weekend to crack down on drunk drivers across the county.

Harris County has had one of the country's highest DWI fatality crash rates for several years. The multi-agency impaired driver task force will focus on preventing alcohol and drug-related traffic incidents and saving lives. Dozens of deputies and state troopers will be out in full force to identify and arrest motorists that make the choice to get behind the wheel while under the influence.

about the dangers of drinking and driving," Harris County Sheriff Ed Gonzalez said. "Every single injury and death caused by drunk driving is preventable."

Memorial Day weekend is a time when families and friends come together to honor and remember our fallen heroes. It also marks the unofficial start of summer, with increased travel and celebrations.

Unfortunately, it is also a time when alcohol-related accidents and DWI incidents tend to rise.

'We urge everyone to make responsible choices, plan ahead, and never drive under the influence. Together, we can make this Memorial Day weekend a safe and memorable occasion for all," Gonzalez said.

People are asked to designate a sober driver, call a taxi or rideshare service, use public transit, or arrange for someone to pick you up.

Drivers suspected of being impaired will be subject to field sobriety tests and no-refusal blood draws. Medical technicians will be on site to collect the blood samples. Prosecutors from the Harris County District Attorney's office will be on site for charges, and district judges will be on standby to review and sign off on blood warrants for suspected drunk drivers.

The initiative enables law enforcement to fast-track the process of investigating a drunk driver.

construction and mining machinery, have suffered the most losses, he said.

The outlook there isn't likely to change, according to a March survey of 137 oil and gas firms. According to this survey, Torres said, over half of those surveyed said they expected the employment in oil and gas firms to remain the same. About 40% oof those surveyed said they expected to see a slight increase in employment in oil and gas firms, Torres said.

The energy sector, while important, isn't the only sector economists are following. In the Houston metropolitan area, he said, five sectors have had double-digit percentage growth. They are trade, transportation and utilities (20.5%), professional and business services (16.8%), education and health services (13.2%), government (13.2%) and leisure and hospitality

As of February, Torres said,

private sector average hourly earnings in Austin (\$33.86) and San Antonio (\$27.78) have leveled off while Fort Worth (\$33.78), Dallas (\$33.51), Houston (\$33.03) have all gone up.

The U.S. (\$33.22) and the Texas (\$31.15) average hourly earnings have also been rising. The U.S. figure was as of March, while the Texas figure was as of February, Torres said.

Looking forward, Torres said, according to the Texas Economic Forecast, jobs in Texas will increase by 2.4% this year. The trend reflects a steady decline, from 4.8% in January and 6.1% in January 2022, he said.

The growth forecast comes as a Federal Reserve Bank of Dallas survey indicates that industry executives expect the industry to continue slowing down and the price of a barrel of oil falls from \$108, in the second quarter of 2022, to an expected \$80 this year. As of press time, the price of a barrel of oil was at \$73.

his daughter, who was struggling to breathe.

A deputy began performing CPR on the child and noticed she had a large bruise on her forehead. The deputy also noticed bruising on the child's ears, arms and legs, and she was wet and cold to the

Charging documents said Maglitto laid on the ground, in a prone position, and began apologizing and said he does not remember what happened. The deputy said Maglitto spoke about God and that "God will take care of it."

The child was taken by Life Flight to Memorial Hermann Children's Hospital in the Texas Medical Center in critical condition because of the severe head trauma, the charging documents said. The child died at 4:57 p.m., shortly after arriving at the

Charging documents said an autopsy was performed on the child. Findings included head and suspicious for torso contusions and a displaced left-sided skull fracture. Such injuries are nonaccidental blunt force trauma, the documents said.

Charging documents said deputies interviewed Maglitto's sister, who said earlier that day she received a text message from Maglitto saying that the child was unwell. At about 12:30 p.m. she arrived at the residence, and found the child in apparently good health. She did not notice any visible markings or bruises, the documents said.

The sister called the child's mother and told her she was concerned about the children, both the threemonth-old-daughter and another, four-year-old child, the documents said.

The case is in the 232nd State District Court.

Katy Rice Harvest Festival reclaims its old name

When the City of Katy took over the annual Katy Rice Harvest Festival from the Katy Area Chamber of Commerce in 2018, officials changed the name, albeit slightly, by dropping the word "Harvest." Officials at the time said the revised name reflected a new era while keeping ties to a local, 40-year-old tradition.

At Monday's meeting, the old name-Katy Rice Harvest Festival-was reclaimed and will once again be the name of the festival.

Ashley Lipsman, the city's tourism and marketing event coordinator, said reclaiming the full name has brought a positive response.

"We may not harvest rice in Katy area like we used to, but we celebrate the history by bringing back our name, the Katy Rice Harvest Festival," Lipsman

The festival, held each October, is among Katy's biggest attractions, drawing tens of thousands of people, both from across Texas and other states. Festival attractions include arts and crafts for sale, children's attractions and rides, live performances on two stages, food, and beverage stations.

The festival began in 1978, when it was called a "Sellabration." Its purpose was to honor local rice farmers and their contributions to the local economy. The festival became known as the Rice Harvest Festival in 1981. Over time, the Katy Area Chamber of Commerce became involved in staging the festival

The festival continues to be held each October in downtown Katy between 1st Street and 4th Street and Avenue A and Avenue D.

Texans choose to wear a seat belt, that still means 10% of Texans make the dangerous choice to stay unprotected on the road.

TxDOT's goal is to get 100% of drivers and passengers to wear their seat belt 100% of the time.

From May 22-June 4, including Memorial Day Weekend, law enforcement from around the state will be working overtime ticketing motorists who are not buckled up. State law requires that every person in a vehicle be secured by a seat belt whether riding in the front or back seat. Fines and court costs for failing to fasten seat belts can add up to \$250 or more.

The National Highway Traffic Safety Administration estimates that the Click It or Ticket initiative has saved more than 7,399 lives, prevented more than 120,000 serious injuries, and

resulted in \$28.5 billion in economic savings since its inception in 2002.

TxDOT's Click It or Ticket campaign is a key component of #EndTheStreakTX, a broader social media and word-of-mouth effort that encourages drivers to make safer choices while behind the wheel to help end the streak of daily deaths. Nov. 7, 2000, was the last deathless day on Texas roadways.

How to 'un-dorm' a college student

very year in late spring, parents of college students all over America travel to university campuses with stylish IKEA storage bags or (in our case) cardboard boxes that once held bulk orders of toilet paper and tortilla chips. When the parents arrive, they joyfully greet their academically-hungover children and start the arduous and sometimes pungent process of "undorming."

My wife and I recently drove in our decrepit but cavernous 2013 SUV to move our middle daughter and her dirty laundry back home from college. Upon our arrival to campus, we were immediately confronted by sympathetic glances from other dads in sweat-soaked t-shirts and beleaguered moms whose expressions belied their incredulity at how their children could possibly have spent an entire academic year living like this.

When we entered our daughter's dorm complex, apparently built sometime during the late Pleistocene era, I immediately began to feel itchy. My sensations didn't improve on our elevator ride to her room as the belt made a screeching noise that sounded like it had recently been repaired with Scotch tape and Flex Seal (as seen on TV).

Once we started the cleaning and packing process, I noticed the following repeated conversations between us and our daughter:

Retired state workers deserve a 13th pension check

Retired state employees have not seen an increase in their monthly pensions since 2001—Rick Perry's first year as governor—and have come together at the Capitol this month to call for action.

State workers dedicated our careers to protecting public safety and serving Texas in many other ways. But too many of the people I served with are now struggling to make ends meet—or working extra jobs just to support themselves.

They live in every county and legislative district. They built the infrastructure that allowed Texas to grow and prosper. And they need help.

My organization, the
Department of Public Safety
Officers Association, is one
of eight employee and retiree
organizations that sent a letter to
the state's top budget writers and
gathered at the Capitol on May 3
to urge them to use a small part
of the state's historic \$33 billion
surplus for a pension increase. The
organizations represent thousands
of the 122,000 retired state workers
and their beneficiaries who receive
pensions through the Employees
Retirement System (ERS).

The groups are asking the Legislature for a 13th pension check for ERS retirees this year, similar to the extra check that retired Texas teachers have received in each of the past two state budgets and are expected to receive again.

A "13th-month check" is a one-time payment that would help retirees ease the burden of inflation and help pay for food, gas, housing, and medicine. In the long

term, the retiree groups are seeking the first cost of living adjustment in 22 years, similar to what retired teachers will receive this year.

"We are deeply concerned that the budget does not include any immediate relief for retired State of Texas employees," retired game warden Larry Young of the Texas Game Warden Peace Officers Association said. "For years, a secure retirement has been vital to keeping good workers providing essential services to the citizens of Texas."

Providing a one-time supplemental 13th check for all ERS retirees would cost only \$250 million in the proposed \$308 billion budget and could be distributed within months without negatively affecting ERS's financial soundness.

"I started working for the State of Texas two days after I graduated high school and continued for more than 30 years after I earned my degree at Stephen F. Austin State University in Nacogdoches," John "Dan" Maxwell, president of the statewide retirees' chapter of the Texas Public Employees Association, said. "My co-workers and I made less than we could have in other jobs because we loved serving Texas. We always thought we would have stability when we retired."

Workers who retired in 2001, the year of the last benefit enhancement, today receive an average pension of less than \$18,000 a year.

"In my 24 years in state government, I saw that my work impacted thousands of Texans, and I was proud to be a state worker," Sandy Smith of San Antonio, a board member of the American Federation of State, County and Municipal Employees (AFSCME), Texas Retirees, said. "When I retired in 2010, it had already been almost a decade since the Legislature had increased pensions for retirees. I never dreamed we would be here nearly a decadeand-a-half later, still with no help."

The other organizations advocating for a 13th check include Texas State Troopers Association, AFSCME Texas Correctional Employees Council, Retired State Employees Association, and the Texas State Employees Union.







Katy will play Clear Springs in the regional semifinals, a team that the Tigers tied 11-11 in tournament play earlier this



Katy took the lead in the bottom of the sixth on a double from AJ Atkinson that drove in Nayden Ramirez.


"I was just looking for something to drive," Atkinson said.

Both Smith and Eason were named to the second team after strong rookie seasons.



year's draft was much better as the season went on, upping his average points per game over his last five games to 15.2, his field goal percentage to 45% and 32% from three-point range as his confidence grew.

Eason averaged nine points and six rebounds per game, with just over an assist and steal per game and over half a block per game. Eason shot almost 45% from the field and 34% from three-point range.


Eason's defensive ability and effort was on full display throughout the season, as he earned more minutes throughout the season and has been a player that Ime Udoka has been excited to work with.
